- Leora Bell, Country Club Hills, told Alderman Spivey that he should not contradict himself. She continued that he should do the right thing, not babble and be respectful and honest about the theater issue. She stated to Mayor Ford that he had sanctioned the "babble"
- Tom Melton, Country Club Hills, requested clarification regarding the additional payroll disbursement approved with the vouchers.
- Hosea Gray, Country Club Hills, asked if vouchers were verified prior to being paid, disagreed with the \$5000 fee for project manager to Mr. Amu as he feels that Smooth Chicago should be managing the theater, inquired as the City's position regarding the agreement with the Park District, questioned the lack of detail for the Park District s monthly payment to the City, and inquired as to the logic of rebates to businesses.
- · Harry William Jones, Jr., Country Club Hills asked for details regarding the resignation and severance agreement with Valeria Densmore.

Alderman Lockett moved that the floor be closed to the public. Second - Alderman Davis. Motion Carried Via Voice Vote.

9. Aldermen's Reports

- Alderman Davis stated that the additional payroll was for fire and police pension funds and group insurance. He announced that Cornerstone Church will be holding a Food Drive on December 29, 2015 from 10 am to noon. He invited residents to attend the tax appeal session on December 16, 2015 from 6:30 top 8:00 pm at City Hall. He concluded by wishing everyone a Happy Holiday.
- Alderman Lockett thanked everyone for their attendance and wished all a Happy Holiday. He thanked everyone for their assistance and contributions at the concert fo the homeless at BelAir Church this past Saturday. He stated that Steven Amu oversees the theater project just as Baxter and Woodman or Robinson Engineering oversee projects and that all contracts go out to bid. He explained that the resignation/severance agreement was of standard form, reminded everyone to enjoy the weather and wished everyone a Merry Christmas and a Happy New Year.
- · Alderman Glispie wished everyone a Happy Holiday and Merry Christmas.
- Alderman Evans stated that the 2014 audit is complete and that a hard copy would be available in January. She noted that the audit is unqualified. She stated that she supported the resignation/severance agreement as it was common and she had no problem with what had been offered. She explained that the tax rebates were given to businesses that were current on their property tax bills and that the City needed to support those businesses that are here in Country Club Hills. She stated that she is tankful for the opportunity to serve the residents and concluded by wishing everyone Happy Holidays.

- Alderman Spivey thanked everyone for their attendance. He stated that the tree lighting ceremony was quite nice and thanked Mr. Ross.
