PROCLAMATION

WHEREAS 20 years ago over 200 residents from City of Country Club Hills and municipalities throughout the Southlands had the foresight to create the organization; South Suburban PADS (Public Action to Deliver Shelter), a community wide response to the growing numbers of individuals and families grappling with the issue of homelessness, and;

WHEREAS the dedicated founders developed an emergency overnight shelter system which emphasizes hospitality, respect, dignity and the empowerment of each person receiving services, and; PADS has delivered over 295,000 nights of shelter and more than 910,000 meals through the efforts of 10,222 volunteers who serve over 60,000 hours each year, and;

WHEREAS the PADS organization provides year-round emergency housing for 1,200 men, women and children through a network of 29 participating host Faith Communities, 250 supporting Faith Communities and the services of 4,000 volunteers, and;

WHEREAS PADS currently operates two (2) PADS Daytime support centers which provide employment readiness, case management, mental health and addiction services through unique programs and community partnerships, and;

WHEREAS PADS has created the Homeless Healthcare Network, which provides medical services in free clinic settings for 850 people annually; the Homeless Prevention Program which distributes emergency funds to support community residents fighting to maintain their homes, and;

WHEREAS the PADS continuum of services includes the Interim Housing Program, Project WIN (Wellness Initiative Network), Project WISH (Wellness Initiative through Supportive Housing), Families First and the Rapid Re-Housing Program, programs designed to transition people from homelessness to permanent housing, and;

WHEREAS throughout the United States, communities continue to struggle with economic challenges and PADS involvement in local, county, state and national efforts to bring an end to homelessness is crucial to the residents of the Southland. Now, therefore, COUNTRY

of CLUB HILLS hereby recognizes South Suburban PADS 20 seasons of service by The CITY " PROCLAIMING the month of January 2010 as South Suburban PADS Awareness Month (and asks its residents to support the organization's efforts to continue serving the community by working to bring about an end to homelessness.)

AN ORDINANCE ABATING THE CITY'S 2009 LEVY AS TO A PARCEL OF PROPERTY COMMONLY REFERRED TO AS THE WAL-MART PROPERTY

WHEREAS, the City of Country Club Hills is a home rule unit of government; and WHEREAS, as a home rule unit of local government, the City may exercise any power and perform any function pertaining to its government except as limited by Article VII, Section 6; and WHEREAS, the City has entered into an Economic Incentive Agreement with Wal-Mart

Corporation, pursuant to which the City is to abate 50% of its property tax levy against the Wal-Mart properties; and

WHEREAS, the current tax year is the third year of the ten year abatement;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COUNTRY CLUB HILLS, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF ITS HOME RULE POWERS, as follows:

Section 1: Abatement. The City of Country Club Hills 2009 tax levy is hereby abated as to the following parcel of property, identified by its Permanent Tax Index Number: 28-27-201-006-0000.

Section 2: Filing. The City Clerk is hereby authorized and directed to cause a certified copy of this Ordinance to be filed in the Office of the Cook County Clerk Tax Extension Department.

Section 3: Home Rule. This ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a)

contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the City of Country Club Hills that to the extent of the terms of this ordinance should be inconsistent with any non-preemptive state law, that this ordinance shall supersede state law in that regard within its jurisdiction.
