Discussion - Alderman Spivey stated that the Council needs to closely consider who the City would like to utilize as a lobbyist. Mayor Ford stated that he felt this should have been discussed by everyone at an Administrative Meeting and that there seems to be a general disregard for the rules. Alderman Davis stated that he had not been involved in the original vote. Alderman SPivey stated that he felt the issue was being taken out of proportion. The following individuals addressed the Council:

Leora Bell, Country Club Hills, stated that the comment made by Alderman Davis that everyone should file a tax appeal is incorrect as an appeal may affect a resident tax freeze status. She also stated that the most efficient way to keep taxes tolerable is to through cutting costs. She stated that the current situation is the result of a Chicago tribune study which resulted in Toni Prekwinkle ordering an independent study.

Alderman Lockett moved to close the floor to the public. Second - Alderman Glispie. Motion Carried Via Voice Vote.

7. Aldermen's Reports

- ♦ Alderman Spivey announced that the 4th Ward meeting will be held on Thursday at 7 pm at the Fire Station. He explained that streets in need of repair had been ranked by the engineering firm and were rated by severity of need of repair.
- ♦ Alderman Glispie stated that he felt the lobbyist should have been given the opportunity to prove his worth. He stated that information should be given to new residents when they move in to provide them with the rules and ordinances of the City.
- ♦ Alderman Lockett invited everyone to the Multicultural Festival on Saturday September 15 featuring over 80 vendors.
- ♦ Alderman Davis thanked Ms. Bell for her comments and stated that most property taxes did increase and that there is a 30 day time frame for appeal.

Mayor Ford stated that the Tribune article had mentioned resident Clifton Graham and that

there are many Cook County residents who pay little or no property taxes and othhjer residents are picking up that slack.

Mayor Ford reiterated that the City engineers assess the worst streets in the City and that not all streets in wards are repaired as the need is determined on a city-wide basis.
