Alderman Davis announced that the Public Works committee had discussed an intergovernmental agreement with Hazel Crest for street resurfacing of Central Park and selection of an engineer for Phase 3 of the 183rd Street and Pulaksi project. He will be bringing these items forward to the Administrative Meeting.

IV. Economic Development, Planning, Zoning & Economic Development Alderman Spivey, Chairman (TBA)

A. Motion for to Establish a Request for Lobbying Service for the City of Country Club Hills

Alderman Spivey moved for Council approval to establish a request for a lobbying service for the City of Country Club Hills. Second - Alderman Davis. Discussion - It was stated that the original lobbyist (Bass)f should have been given an opportunity to perform. It was also stated that the original contract for Bass had been approved after work had begun. Mayor Fiord stated that the Council had approved Bass as a lobbyist.

VI. Special Committee of the Whole Outdoor Theater

Alderman Lockett moved to open the floor to the public. Second - Alderman Glispie. Motion Carried Via Voice Vote.

The following individuals addressed the Council:

- ♦ Les Harris, Country Club Hills, stated that he felt the City did not need a lobbyist as that should be the responsibility of the aldermen and the Mayor.
- Leora Bell, Country Club Hills, stated that at the pervious meeting she had suggested cutting spending to lower taxes. She distributed information indicating the salary levels of elected official in the SSMMA and suggesting that the lowering of the pay of aldermen and elected officials would save the City money.
- ♦ Hosea Gray, Country Club Hills, stated that he was concerned that the CDBG grant would be used for housing and not streets, agreed that a lobbyist was not necessary, requested that the Mayor explain the ability of the Park District to attend "junkets" and inquired as to the cost to the City of the solar panels discussed at the Administrative meeting.
- ♦ Dwyer Williams, Country Club Hills, stated that he also felt that a lobbyist was not necessary, thanked the Police Department for a speed watch sign, asked residents with damaged garbage cans to contact Homewood Disposal for replacement and/or repair and wanted to know when street resurfacing would begin.
- ♦ Faustine Percival, Country Club Hills, addressed the Council and inquired as to the status of the water situation with Oak Lawn. She also stated that she had contacted Public Works regarding the condition of the streets at 177th and Larkin Lane.

Alderman Lockett moved to close the floor to the public. Second - Alderman Davis. Motion Carried Via Voice Vote.

7. Aldermen's Reports

- Alderman Davis stated that street repairs should begin by the end of the month as the bid package has been sent to IDOT. He stated that financial issues needed to be addressed as fire vehicles had been purchased prior to Council approval and that he had not been at the meeting approving the lobbyist but that he always supports the proper process.
- Alderman Lockett stated that the lobbyist is in the budget as are the fire vehicles. He stated that the aldermen are responsible for policies and purse strings and are not lobbyists, nor is the Mayor. He stated that the current water report is on the City's website and that the City is working, along with other communities, regarding the Oak Lawn water issues. He concluded by asking residents to support the City's Halloween Happenings event on October 31, 2018.
- Alderman Glispie stated that water could possibly be procured through Chicago Heights and/or Hammond. He stated that the lobbyist should be given a chance to show what he could achieve for the City. He thanked those residents making the effort to keep the City beautiful by maintaining their grass and picking up litter. He mentioned that there is a resident of Ward 2 who has been picking up litter along Pulaski for over 20 years.
- ♦ Alderman Spivey stated that a Ward 4 meeting will be held on October 25 at 7 pm at the Fire Station, with no meetings in November or December and a resumption of meetings in January. He thanked School District 160 and Channel 4 regarding the HBC Classic, stated that he had alerted Jerry Townsend to street light outages in Ward 4, invited everyone to attend an event at UIC on October 13. He stated that there is \$30,000 in the budget for a lobbyist and he stated that we should get the best for our money.

Mayor Ford stated that there had been discussion prior to the approval of a lobbyist and asked Adleman Spivey if he had a particular individual in mind. Alderman Spivey responded that he had an individual (Monica Gordon) that could be considered as a lobbyist candidate.

Mayor Ford distributed his veto of the termination of the Bass Group Contract.

Mayor Ford continued that he was sure that the residents did not want their Mayor to spend his time in Springfield and that the fire vehicles were in the budget. He suggested that questions for the Park District be directed to the Park District at their meetings and that we should all work together. He announced that the small business workshop, sponsored by DCEO, will be October 17 from 5:30 to 8 at the pavilion.

Attorney Nelson-Jaworski asked to be recognized and provided the opinion that the Mayor was not able to veto the termination of the Bass contract.

8. Adjournment

A Motion to adjourn was made by Alderman Lockett. Second - Alderman Glispie. Motion Carried Via Voice Vote and hereby made a part of the original journal of proceedings this date.
