## CITY OF COUNTRY CLUB HILLS REGULAR MEETING OF THE CITY COUNCIL February 25, 2019

- 1. A regular meeting of the City Council, City of Country Club Hills, County of Cook, State of Illinois, was held in the City Hall, 4200 W. 183rd Street at 7:00 p.m. The meeting was called to order by the Honorable James W. Ford, Mayor.

Ursula Anderson, Country Club Hills stated that her property taxes have increased each and every year since 2015. Mayor Ford stated that the Council has not raised

- the City's portion of the taxes in 6 years.
- Derrell Thomas, Country Club Hills, questioned the public portion of the meeting being moved to prior to the committee reports.
- Gino Williams, Country Club Hills, stated that he agreed in questioning the moving of the public portion of the meeting.
- A resident addressed the Council and questioned the number of possible home based businesses in the neighborhood including a semi truck and a possible cab company.
- James Craig, Country Club Hills, addressed the Council and stated that he wanted to comment on a mayoral candidate having missed 6 of 38 scheduled meetings in the past year, having voted against a number of vouchers and had several judgements of foreclosure (information he stated he obtained form the Cook County website).
- Gino Williams, Country Club Hills, stated that he was not in attendance during the most recent treasurers report and questioned the validity of voucher payout.

Alderman Lockett moved that the floor be closed to the public. Second - Alderman Glispie. Motion Carried Via Voice Vote.

- 7. Aldermen's Reports
- ♦ Alderman Davis congratulated the newly-appointed volunteer commissioners. He stated that the City has not raised the tax levy in several years; however, increases may be the

result of other taxing bodies raising their levy. He stated that he felt changing the agenda order regarding the public portion of the meeting was an attempt to confuse the public, that attendees are encouraged to record the meetings, that the City can check on hone based businesses. He concluded by thanking Alderman Evans for expressing her opinions and providing support.

- ♦ Alderman Lockett announced the passing of George Carter.
- ♦ Adermin Glispie thanked the newly appointed volunteers and stated that he is looking forward to working with them.
- Alderman Evans explained that different taxing bodies' portion of the collected property taxes, stated that opening the floor to the public at the beginning of the meeting was a mistake made by the administration, stated that it has been "silly season" for 4 years, that a loan of City funds had been made to a city employee, that there are not sufficient funds in the City's bank accounts, that there are gross errors in the City's payroll and payroll system, that there are too many "super-users" in the payroll system, that the Mayor is responsible for a 16 million dollar verdict and that the City considered hiring a registered felon to work at the CRC. Se stated that home based businesses can be verified by City staff and that the City will be financially "ok" when the property tax money is received; however, the shortages will continue to occur. She encouraged residents to file Freedom of Information requests.
- Alderman Spivey announced that a 4<sup>th</sup> Ward meeting will be held on Wednesday at 7 pm. He stated that he agreed with statements regarding property taxes made by his fellow aldermen.

Mayor Ford stated that may remarks made were not completely true. He stated that an 80 million dollar project with Logistics is underway with a groundbreaking to be held soon. He stated that as of March 1, 2019 he was proposing that elected officials that not attend meetings not be paid for time not in attendance. The treasurer asked to be recognized. Mayor Ford did not recognize the treasurer's desire to speak. Alderman Davis moved for Council approval to allow the Treasurer to speak. Second - Adleman Evans. Mayor Ford continued by requesting that proof of mismanagement of funds be provided, that the former Mayor is telling residents that the City is bankrupt, that the employee was not given a loan, that we need to be respectful of one another and provide solutions, not criticisms. Heated discussion ensued with Alderman Evans moving to override the Mayor's decision to not allow the Treasurer to speak
