# 5. COMMUNICATIONS AND REPORTS BY MAYOR FORD:

Mayor Ford shared the city's newest restaurant Hook & Reel is open and will hold their grand opening ceremony Friday September 18th. Mayor also shared Wing Stop will be coming to Country Club Hills in the near future as well. Mayor Ford shared the Logistics project is making progress and the 2nd building is expected to open early November. Mayor shared there is a Southland Black Chamber of Commerce soliciting businesses in Country Club Hills and the Southland. The Black Caucus of Mayors has schedule a meeting with this entity to find out who they are and where they are from as they have solicited 4 businesses in Country Club Hills to join their Chamber of Commerce. Mayor Ford was upset that the Southland Black Chamber of Commerce solicited businesses without contacting the Mayor and they are operating without a solicitor's license. He did find that this entity is based out of Peoria and claims to be the premiere Black Chamber for this area. The Black Chamber has contracted with Hook and Reel to hold a Ribbon Cutting Ceremony and this cannot happen because the City has a Chamber of Commerce and the Economic Development Commission that will promote the Ribbon Cutting. Mayor lastly shared last Saturday Hillcrest Baptist Church had a fantastic Food Giveaway Program and gave away 14 skids of boxes of meats. This Saturday 10am to 1pm the City will give away face masks, book bags, 2020 Census officials will be on site along with Voter Registration at the Pavilion.

# 6. CITY CLERK'S REPORT – PATRICIA D. HUTSON, CITY CLERK

City Clerk Patricia D. Hutson shared early voting begins October 19th and the local sites are Markham Courthouse and Matteson Community Center. All voters have the option of early voting, mail in ballot or tradition in person voting. Branch pick up dates are set for October 10 – South of 183rd St., October 17th – North of 183rd St and Street Sweeping is October 12th – South of 183rd St. and Oct 19th – North of 183rd St. This information will be shared on Facebook and the website. City Clerk Hutson reiterated the upcoming mask, book bag etc. giveaway and thanked our partners i.e. Com-Ed, AT&T Pioneers, U.S. Census, SD#160, Grande Prairie Library for their assistance.

# 7. CITY COLLECTOR'S REPORT – PATRICIA D. HUTSON, CITY COLLECTOR

Mayor shared the financial status of the City. The City has been working with Cook County on the CARES Refund Program to obtain \$520,000 in monies spent since COVID-19 began. The city has spent \$2.1million. Payroll for the city totals \$600,000 every two weeks. The \$520,000 will help but we are still struggling financially. We are also waiting to see what happens with the taxes from residents and businesses who have not paid taxes due to COVID. The finance committee will look at cost cutting measures moving forward in the future. Mayor has asked staff to limit spending at this time.
