A regular meeting of the City Council, City of Country Club Hills, Cook County, State of Illinois, was held in the City Hall, 4200 W. 183rd Street at 7:03p.m. The meeting was called to order by the Honorable James W. 9. PUBLIC PORTION OF MEETING (3 MINUTE PER PERSON LIMIT)

Theresa Lipsey, resident thanked the Mayor and council for the opportunity to speak. Ms. Lipsey shared her concerns regarding the water bills. She appreciated the Mayor's acknowledgement that he will has addressed this with his staff and mentioned it would be nice for the Mayor to send something out to the residents as the leader of this city to comfort the residents apologizing for the mistake. Ms. Lipsey thanked Clerk Hutson for explaining the water bill issue earlier in the lobby. Ms. Lipsey shared she appreciated the acknowledgement of

Breast Cancer Awareness month as she is an 8 year breast cancer survivor. Ms. Lipsey then shared she hopes this does not happen again because it was a bit of a sticker shock when she opened her bill. She asked if this will be an issue in the future. Mayor Ford shared he does not see this as a issue in the future. This is the first time this has happened since he has been in office and he has been working with staff to identify the problem to make sure this does not occur again. Ms. Lipsey shared she has spoken with Ald. Spivey about the speeding near her home ATV's and vehicles. She called the police department 4 times and went out to look for the speeders in her area. The speeder are frequenting her area near 189th St. Ald. Spivey has organized police and the mobile speed identifier. Ms. Lipsey shared in the August 4th council meeting that Mayor Ford shared the number of renters in town which was over 900 residential properties. Ms. Lipsey shared she understood the rental program was suspended and she is now concerned about the rental properties. She is a proud home owner and wanted to know if the program is suspended what is the city going to do to address the unattended maintenance of the properties that the current renters reside in? Ms. Lipsey shared there is a caucasion gentleman on her block this has to be afraid because the renters in one particular property throw trash in the middle of the street and the yard is not maintained. Mayor Ford shared this is why we need to do something different with our rentals, all renters are not bad people and everyone needs a place to stay. We cannot afford to let the renters trash while home owners suffer. Mayor will have the Building Department enforce the city codes. Lastly, Ms. Lipsey shared 4311 W. 189th is selling used cars out of his driveway. He spray paints cars in the driveway. Mayor Ford shared this gentlemen is a homeowner and we will continue to address this to a point of resolution. Ms. Lipsey shared as the diversity changes she wants to be sure the community is well maintained.

Joy Hudson, resident has a concern with the local youth. Recently she noticed youth rumbling through the mailboxes in the area around 3am ish. This is one of the reasons she requested the tree trimming on the parkway, to give her a better view when this are happening around her home and prevent youth from hanging on the tree. Ms. Hudson thanked the Mayor and the council for their time.

Debrel Adams, resident shared her concern with the water bill and lack of notification of a problem. Mayor shared he was not aware of the problem until the bills went out. The bills were late this month due to machine maintenance issues and asked Ms. Adams see the supervisor at the front desk to review and credit her account. Mayor asked if she received the robo-call regarding the late bills and Ms. Adams replied she did not. Ms. Adams will reconfirm her sign-up with the supervisor of water. Ms. Adams asked what created this and Mayor replied there was a problem with the readings that generated a \$200 bill as opposed to a \$50 bill.

Carmen Maddox, resident has water bill concerns and inquired as to whether this was an equipment or personnel issue? Mayor Ford responded this was a personnel issue related to the pandemic. The city furloughed off 46 people and this has been corrected. Carmen asked if it was a area concern and Mayor shared there were 16 routes but were not able to read all of them everything has been corrected and back to normal.

Frank Bell, resident shared he attended last week and spoke with Mr. Townsend who did not call him and does not agree with the amount due. His bill quadrupled and he needs this resolved. Ms. Bell shared his toilets are very new and Ald. Lockett asked if anyone had give him

a dye tab to check his toilets. Mr. Bell shared he was not given dye tabs. Mayor Ford asked him to speak with the supervisor in the lobby to address his concern.

Helen Myers. resident shared her on October 8th her HOA (Country Club Estates) had a company digging 18 inches and had not called JULIE and hit the cable. She asked them about it and they stopped digging, shut it down and restarted the next day. This interrupted her daughter's online classes with Emory University. Ald. Spivey advised Ms. Myers she is in the 5th Ward and Ald. Davis is her Alderman.
