Mayor Ford began to organize the public to be heard during the Public Hearing portion while managing social distancing during the current COVID-10 Pandemic.

Roxanne Quarles, Michelle Brown, Theresa Hornsbruch, Felecia Koonce, Luis & Laura Gonzalez and several others concerned citizens from the LeClaire St. unincorporated subdivision are shared their concerns and questions regarding the Redevelopment Plan. The questions were regarding notification, taxes, street maintenance, tax breaks for the business, peace and tranquility of the area, unsightliness of the area, construction, well water purity & EPA concerns, eminent domain and interruption of access to their subdivision. The CRG Developer Team inclusive of their Attorney Katie C. Jahnke Dale. Mayor Ford and the CRG team responded to the concerns i.e. the Public Hearing notifications were shared online via the Country Club Hills website, Country Club Hills lobby, City Hall front counter and in the South Suburban Newspaper. The current owner was looking to sell and the developer was looking for land to develop. The previous occupant was the Girls Scouts of American who was tax exempt. The developer is waiting for confirmations from IDOT on street revisions. There are no current tax breaks for the development. The Redevelopment plan was shown to those in attendance and will be pleasing to the eye. There are no plans to disrupt the current use of well water in the subdivision. The development is not yet at the point where there is EPA findings in place. There are no plans to impart on any private land. There was an exchange of questions and answers presented regarding the Redevelopment Plan resulting in responses given.

Clifton Graham, resident had concerns as to why the developers decided to implement their plan in Country Club Hills and if there were any perspective tenants for the site. CRG shared they do have prospective tenants but were not at liberty to share at this time. Mr. Graham also asked about the property taxes to be paid... per Attorney Murphey there is almost next to none because the Girl Scout's were tax exempt and the amount to be paid is up the Cook County. Mr. Graham asked about the TIF amount for the project. Attorney Murphey the current plan is 75% (to help the developer attract new tenants) for the developer and 25% for the city of the city portion. It is anticipated that in 3-4 years the city should receive substantial TIF revenue for the city. Is there a projected revenue for the business? That is a risks assessment question and that is determined by the market.

Jean Pate, resident had concerns regarding lack of notification and property taxes and plans for relief. Alderman Lockett shared the new developments are made in hopes of relief in the future. There were ongoing exchanges of concerns and responses between Alderman Lockett and Ms. Pate. Ms. Pate finalized by sharing she does not know what she is going to be looking at in her backyard.

Zachary Dumas, resident shared his displeasure lack of notification and with having a logistic style development eyesore behind his home along with tax breaks. Mr. Dumas also had concerns about the water and rain flow and how the development will impact his home. The developer shared there is no perfect plan to avoid excessive rain flow at his property. Mr. Dumas asked if there would be an increase for our current 24% tax rate. Mayor shared he could not guarantee anything at this point. Alderman Lockett shared if the city does not have a vision and move forward with new development and new businesses the city will not be able to pay for city services. Mr. Dumas shared the tax rate was 17% when he moved into Country Club Hills in 2002.

Sandra Kirk-Franklin, resident asked for clarity of the development plan to be shown on the map of the Plan.
