11. PUBLIC PORTION OF MEETING

Theresa Lipsey, resident shared per our attendance of the 10.12.20 Council Meeting, where she shared her concerns about the Water Billing issue, she followed with an email to Mayor Ford, Chief Galvin and City Clerk Hutson regarding 4311 W. 189th St and speeding. Ms. Lipsey received a response from Chief Galvin and Clerk Hutson but not from Mayor Ford. She shared her disappointment that Mayor Ford had not responded to her email. Ms. Lipsey shared her concern with the lack of accountability by landlord for their rental properties. Ms. Lipsey shared she has lived in Country Club Hills since 2018 and she had noticed changes over the last year and a half. Ms. Lipsey has spoken with her neighbors about their concerns and encouraged them to attend the City Council Meetings and voice their concerns. Mr. Lipsey reached out to the National Home Association which owns several rental properties in Country Club Hills and they will not address the property concerns. Ms. Lipsey shared she sent Mayor Ford a 3 page email regarding 4311 W 189th selling vehicles at the property and looked at a Facebook page to see the occupant was sharing the vehicle sales at the property as well. Ms. Lipsey shared she did not believe that Mayor Ford is a Mayor for the people or for her. She shared she voted for him and now has a different opinion. Ms. Lipsey spoke with Ald. Spivey about a Stop Sign request at 189th Willow, Ms. Lipsey shared Ald. Spivey said the survey was complete and she wanted to know when the Stop Sign will be installed because the sign is needed. She has been hearing about this Stop Sign since August. Ms. Lipsey said this is a safety issue and someone is going to get hurt.

Mayor Ford shared that Chief Galvin and City Administrator Carl Estelle had been directed by Mayor to address her concerns and respond on his behalf. Mayor shared Ms.Lipsey can vote for whomever she pleases. Mayor shared he receives several thousand emails and although he may not directly respond he will have a staff member respond on his behalf.

Ald. Spivey shared he did have a study complete per his request to Chief Galvin and it was left with Jerry Townsend to complete the process by finalizing it with Mayor Ford. Ald. Spivey said per correspondence, which is on his phone, the item was continually pushed back. Ald. Spivey said he went through the proper channels with the Police Dept and Public Works. When this was brought up at the last meeting Mayor said he did not know anything about it. Ald. Spivey

shared he did not go to the Mayor he went to the departments. Ald. Spivey shared he had a yield sign on Walnut installed and there were no problems.

Mayor Ford shared a yield sign can be installed without a vote. Mayor Ford shared he has not received anything on his desk for a Stop Sign. Mayor shared a Stop Sign has to have an Ordinance. Mayor then shared to Ald. Spivey that there is a process to have the Stop Sign request complete and it starts with the Alderman contacting the Mayor and not directly contacting staff. The Mayor will have the study complete with the Police Dpt. and Public Works, the item then goes to Committee to Admin and then goes to the full Council for a vote.

Ald. Spivey requested the records show he was not telling his constituents that the Mayor was holding up the Stop Sign installation.

There was ongoing conversation with Mayor Ford an Ald. Spivey and Mayor Ford shared again he has directed City Administrator Carl Estelle to complete the request.

Ald. Lockett asked everyone to keep Rosemary Gage and her family in your prayers because she recently lost her husband, Bobby Duka, and Rosemary passed earlier this week.

Ald. Davis asked for prayers for Alice Jessup's family, of 186th and Becker, she recently passed.

Mayor Ford asked for prayers for, longtime and highly admired Southwood Middle School teacher, Mr. David Pope who recently passed away.

Mayor Ford shared he understands everyone is running for re-election however, received two campaign literatures which has the city address and phone number on them. He asked everyone to please refrain from using the city address and phone number on political literature. Ald. Spivey asked if you put out a calendar it represents the city. Ald. Glispie shared you should be able to use your cell phone. Ald. Spivey shared as Aldermen they represent the City and should be able to use all methods. Mayor shared when you are campaigning you have to use your own information with your literature. Ald. Evans said what needs to be discussed is the difference between campaign literature and sharing information. Mayor Ford shared cell phone numbers can be used instead of City Hall. Ald. Evans shared she thinks it's better for residents to call City Hall instead of calling her and referring the resident back to City Hall and they should have the Alderman's phone number as well. Mayor Ford shared this has not be done this way in the past and he has set up a meeting with Attorney Murphey on Wednesday and they will resolve these concerns.
