11. PUBLIC PORTION OF MEETING

Ronald Winston, resident had a couple of questions about Parks and Recs. He would like to see softball return and bring in a small stream of revenue. Also, he knows the snow is coming and he would prefer if we can find a resolution for the snow mounds at the end of resident's driveways as the snow is plowed. Mr. Winston also spoke about the lack of expansion of the roads on 183rd St. Lastly, Mr. Winston would like to see technical and physical after school programs. Mayor Ford shared his interest for the men's softball team and IDOT is working on the expansin of 183rd St.

Helen Myers, resident thanked Pastor King for his prayers during the meeting. Ms. Myers asked if occupancy laws and city ordinances work parallel? There was low level conversations as the council was in need of point of clarity. Ms. Myers shared to obtain a certificate of occupancy one needs to have running water, electricity and heat. She then asked about the laws and safety laws because she has received incorrect information from the Building Commissioner. Ald. Lockett shared there is an issue with her heating and Ms. Myers shared she is not going to discuss her personal issues. Ald. Lockett shared we cannot help if we don't know what the concern is. She was not told to bring it to the public. Ms. Myers shared this is a public health and safety crisis. She does not have heat in her home and she is being stopped from putting heat in her home. She shared she is a disabled woman and she belongs to an HOA. She shared her HOA does not have the right to stop her from putting heat in her home. She said she spoke with the State of IL. She said she is attached to an elderly woman and she could possibly blow her house down if her house blows down. Mayor Ford shared Attorney Murphey will respond. Attorney Murphey responded if this is an HOA issue it is not a city issue. Ms. Myers said she spoke to the state and this is a health crisis because there is no heat. Ald. Lockett shared it is not the city it is your HOA. Ald. Lockett asked is it the HOA that will not allow you to put the HVAC unit in your home? Ms. Myers said she cannot have it installed without the permit and she received a permit today. She said the environmentalist sent the permit in today. Ms.. Myers said the problem is the unit cannot be installed for building structure. Mayor Ford then shared the Building Commissioner cannot force the HOA to accept a unit that goes against their bylaws. Ms. Myers said she wants a ticket to be issued for the no heat violation. Ald. Lockett said she has occupancy already. There was ongoing discussion with Ms. Myers and the City Council Members. Mayor Ford then shared Ms. Myers can speak with the attorney after the meeting.

Leroy Barnes, resident asked about the Committee meetings...are residents invited? Regarding the IDOT and MFT maintenance is this how the cameras will be funded? Regarding the development last Wednesday 6:18am three was an 18 wheeler on his block. Mayor Ford shared the 18 wheeler was an isolated incident and that should not happen again. Also Mayor Ford shared during tonight's meeting the council passed an item that includes a license plate camera reader.

Zachary Dumas, resident shared he is waiting for a response from the project manager per previous council meetings. He shared he didn't believe the information was shared when the project started because if so residents would have responded as they are responding now. Lastly, he shared if there is a meeting planned to please let the residents know.

Margaret Clark, resident, who works for Walmart and asked who is responsible for the Walmart potholes. Ald. Lockett shared that is Walmart's responsibility. Ms. Clark then asked for a small business grant app and Ald. Lockett shared it will be available after the meeting.

Ald. Edwards shared he would like Country Club Hills to share information with Bremen Township to be included in their news booklet. He shared 171st and Appletree and Peartree is in need of street repairs. He shared at 177th Hillcrest the lights are out for 3 months. In Ward 1 tree trimming and potholes are a problem in Ward 1. He then shared we need to have our programs up and running and asked about a financial discrepancy under the Theater account.

Ald Spivey thanked Director Agpawa for the driveway and street resurfacing in the 4th Ward. Ald. Spivey then shared he is working with a gentleman who can set up a STEM program and share it with the recreation center.

Ald. Evans shared the Senior Snow Removal Application was in the October water bills and there is a cut off number of applicants and date for the program per staffing and safety. Ald. Evans shared she will have a Town Hall meeting for follow up CUBES discussion Nov 4th 6pm with a project manager. Ald. Evans shared the packets will be available after the meeting.

Mayor Ford shared the Small Business packets will be shared by the Aldermen.

Ald. Lockett asked everyone to wish the City Clerk a Happy Birthday. He then asked for prayers for the Southland and the country. He said the gun violence is terrible, be careful while you're shopping. Ald. Lockett then shared there are opportunities for candy Saturday and Sunday in Country Club Hills.

Ald. Davis shared his concerns about the snow at the end of the driveway in his ward as well. Ald. Davis then inquired about issuing tickets to Walmart for the potholes to encourage them to take care of the potholes. Ald. Davis also shared he would enjoy softball as well.

Mayor Ford shared he will have the city inspectors check the Walmart parking lots tomorrow. Mayor then shared his interest for softball and other competitive sports programs for adults and youth in Country Club Hills. There was ongoing conversations about this subject with the Mayor and the city council. Mayor shared he would love to see activities and camaraderie as opposed to the recent violence experienced everywhere.
