A. Pastorial Commission Swearing-in for Pastor Llewellyn Dixon of Jubilee Faith Community

Mayor Ford shared information on the upcoming vehicle light repair program schedule for Thursday February 17th from 9am to 12pm sponsored by Cook County Sheriff Tom Dart and Cook County Commissioner Deborah Sims. The event will be held at the Country Club Hills Police Station. The event will also provide vaccine shots and COVID testing as well. Mayor Ford then shared CCHPD held resting for new officers Saturday February 12th. There were over 25 applicants and the city looks forward to more officers joining the force. Mayor Ford also shared information on a Virtual Contractor's Outreach Fair with Clayco to be held Friday February 18th from 5pm to 6pm in coordination with State Rep Debbie Meyers-Martin and the information will be on the city Facebook page. Mayor Ford thanked Jerry Townsend for his work towards the city receiving \$300,000 from Cook County from the Community Development Block Grant Program. Mayor shared this will enable the city to complete much needed street repairs throughout the city.

Mayor Ford announced the city will swear in Pastor Llewellyn in as a member of the Pastoral Commission. Mayor Ford then introduced and invited Pastor Llewellyn Dixon of Jubilee Community Church to the podium to share information about himself. Pastor Dixon shared he has been pasturing the church for 2.5 years and was preceded by Pastor Michael Russell who pastured for many

years. Pastor Dixon shared he and his late wife Angela Dixon have five children and he prays to continue to serve with his heart.

9. PUBLIC PORTION OF MEETING

Cheryl LeBlanc, resident shared her concern regarding multiple attempts to contact the Public Works Dept. via phone and email. She contacted Director Agpawa, Lenda and Mike Kuta. She shared has lived in her home for over 30 years and is now a retired teacher and administrator. has paid her taxes and maintained her property. She shared on November 28, 2021 raw sewage entered her home. She called her plumber Jimmy, who also does work for the city, he informed her the city line was backed up. She called and spoke with Lenda who said she would send an email to Director Agpawa. She then went to the Operation Center and spoke with Mike Kuta and Derrick and they came out, took pictures of the black slug and sewage and determined that they needed to call Sevrpro per perform the cleaning for the entire lower level of her home. Servpro came out and removed the floors and the walls. She then shared her clothes, shoes and etc were all affected by the backup. Ms. LeBlanc tearfully continued to share she has not had any contact to correct this since November 30th and there has been no work to restore her home. The city referred her to a man by the name of John Turner from National Catastrophe Solutions o determine the cost of restoration. He advised her to go to floor and décor and she has not heard from anyone and that was January. She called Mike Kuta who said they were working on it. She shared as of today February 15th the lower level of her home is still in disarray and the Servpro bill is outstanding and they will not return until the city pays them. Servpro says they have sent bills to the city and they have not been paid. She shared her downstairs toilet is disconnected, the floors and walls are gone and she has dirt and dust in her home and she has sickle cell. She also shared she found out today that her sister has cancer and she needs her home restored. She shared she has pictures and this was not the first time she has had a backup in her home. She pleaded for help to resolve this matter. Mayor Ford shared the \$7,000 Servpro bill has been paid and there was a meeting this morning to discuss the remaining restoration plans. Mayor Ford shared full restoration per Servpro will be approximately \$20,000 and they were looking at other proposals as well. Mayor Ford then shared to Ms. LeBlanc he would like to discuss the restoration with her and her insurance company because some of this could be insurance related. Ms. LeBlanc then shared she will not use her insurance because she should have to pay a deductable and have this go against her as a homeowner because this was not her fault. Mayor said ok. Mayor asked her to see his staff before she leaves regarding a response.

Alderwoman Evans shared her Law and Ordinance meeting will be held Thursday March 3rd at 5:30pm. She also shared the Ordinance for controlled sales is to work with the city and establish a partnership as a preventative measure. Lastly, Alderwoman Evans shared MV Terminals development will not be an eyesore to those traveling on Cicero.

Alderman Lockett shared Happy Belated Valentines Day and South Suburban College will hold an Art Design Show Art Exhibition tomorrow 6-8pm. Also he asked everyone to stay safe and get ready for the snow on Thursday. Lastly, he asked that residents do not call their Alderman or City Hall regarding snow removal.
