ORDINANCE NO. OA-1-22

**AN ORDINANCE AMENDING CHAPTER 13, ARTICLE 3
OF THE COUNTRY CLUB HILLS CITY CODE,
“SALE AND CONTROL OF ALCOHOLIC BEVERAGES,” BY ADDING A NEW
SECTION 13.3.29, “REPORTING DISTURBANCES OCCURRING ON OR
ABOUT A LICENSED PREMISES”**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF COUNTRY CLUB HILLS, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE CITY'S HOME RULE POWERS, as follows:

Section 1: City Code Amendment. Chapter 13, Article 3 of the Country Club Hills City Code, “Sale and Control of Alcoholic Beverages,” is hereby amended by adding a new Section 13.3.29, “Reporting Disturbances Occurring on or about a Licensed Premises,” as follows:

- (a) For purposes of this Section:
 - 1. “Premises” means both the interior of a licensed premises and any parking area under the control or ownership of the licensee.
 - 2. “Breach of the Peace” means any conduct which interferes with the (i) peaceful enjoyment of a licensed premises by the patrons of that premises, or (ii) the peaceful enjoyment of property near the licensed premises by owners and occupants of such property.
 - 3. “Promptly” means at earliest reasonable opportunity.
- (b) Every licensee and licensee’s agents and employees shall promptly notify the Police Department upon the occurrence of any of the following at the licensed premises:
 - 1. A fight, brawl, or similar disturbance.
 - 2. Any apparent violation of a state or local law.

3. The presence of a firearm on the premises.
4. The presence of illegal drugs on the premises
5. Any other breach of the peace.

(c) 1. Each licensee shall install and maintain an interior and exterior audio-video security system for the licensed premises. Any licensee which does not have such system shall install such system within six (6) months of the adoption of this ordinance.

2. The licensee shall preserve audio-video records relating to an incident reported pursuant to this Section for at least sixty (60) days from the date of the incident, and make it available to the police department upon request

Section 2: **Effective Date.** This Ordinance shall be in full force and effect immediately upon its passage.
