Fire and Police Commission Swearing Ceremony

Mayor Ford asked Clerk Hutson to swear in Interim Fire Chief Michelle M. Hullinger as the Country Club Hills Fire Chief. Clerk Hutson proceeded to swear in Interim Fire Chief Michelle M. Hullinger with the Oath of Office as Chief of the City of Country Club Hills. Clerk Hutson then presented Chief Hullinger with a Certificate of Oath to commemorate the swearing in and Chief Hullinger was pinned by her daughter Keagan. Mayor Ford asked Chief Hullinger to say a few words. Chief Hullinger shared she looks forward to continuing to serve the residents of Country Club Hills in her official leadership role as chief along with Deputy Chief Stegenga to serve the residents of Country Club Hills.
