Rudy Little, resident, shared his concerns with street repairs especially on 167th St. near his home and the repairs stopped just before his house. He shared the streets are in terrible condition and appearance matters. He then shared the Wal-Mart shopping carts are left in his neighborhood, there are children walking in the streets and vehicle parking is out of control. Mr. Little shared many homeowners have more vehicles than they have parking accommodations for.

Rachel Fisher, resident, shared she has been picking up trash for quite some time and she would like to see fines issued to the offenders. She shared she picks up food containers, liquor bottles etc and she is now concerned about her property value as this seems to be the norm. Ms. Fisher shared it was not like this when she moved to Country Club Hills and she would like to see a resolution to this ongoing problem. She also shared her street was in great condition then a waste hauler truck came down the street and left a stain on her street in the middle of the entire block. She would like to know if public works can clean it and shared it would not be acceptable in other towns. Lastly, she shared she reached out to Ald. Davis and will follow up with him for assistance and to find out who her alderman is.

Harry William Jones Jr., resident, shared he recently read the fake news regarding Ald. Davis attendance. He shared he was not as concerned about his attendance at the council meeting as he is whether Ald. Davis is addressing residents concerns and servicing his constituents. Mr. Jones then shared members of the City Council were not present tonight including the Treasurer who is never present. Mr. Jones then shared there a snake on the council and Ald. Spivey is the snake. He shared Ald. Spivey is the weak link. He then shared EDC has not brought any new businesses to Country Club Hills. He shared Ald. Spivey is trying to discourage Ald. Davis from running in the next Mayoral election and regardless of his efforts Ald. Spivey will not win. Mr. Jones pledged his money and his vote to Ald. Davis for whichever direction he chooses to take.

Nancy Switzer, resident, shared her parkway has been repaired and the sidewalk she shares has been repaired as well. She shared she has a stop sign at her property and she too has a littering problem from fast food establishments on 167th St. Lastly, she shared she would like to see the littering problem addressed.
