He shared he previously received a normal bill for months and them received a \$217.00 bill for 19,000 gallons which he didn't think he used. He shared he does not have a pool. Mayor Ford asked him to see Jerry after the meeting and someone will look into it.

Clifton Graham, resident, asked for petition information and then proceeded to share the Black Caucus will hold a meeting in Hazel Crest tomorrow and asked why the information was not shared. Mayor Ford shared the meeting is for Mayors. Mr. Graham then shared he would buy all 13 abandoned properties in Country Club Hills for \$100,000 cash.

Harry Evans, resident, asked about the 183rd Street project and why the city would allow the CDBG Grant to disfigure a perfectly good concrete street and replace it with asphalt. Mr. Evans shared that 183rd Street is the greatest street in Country Club Hill. Mayor Ford shared it's not

the city's decision it's up to Cook County engineers to determine the repairs needed. There was ongoing discussion regarding this matter.

Florence Taylor, resident, shared she has resided in Country Club Hills since 1987 and her bbox was located in the driveway, moved and she needs her landscaping repaired from the move by Country Club Hills.

Ald. Davis shared the 183rd Street project is an Invest in Cook and the city added \$600,000 for the CDBG (neighborhood streets). He shared 183rd Street is a County street.
