**AN ORDINANCE AMENDING SECTION 6.2.02
OF THE COUNTRY CLUB HILLS CITY CODE,**

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF COUNTRY CLUB HILLS, COOK COUNTY, ILLINOIS, IN THE EXERCISE OF THE CITY'S HOME RULE POWERS, as follows:

Section 1: **6.2.02A Amendment.** Section 6.2.02A of the Country Club Hills City Code, "All Night Parking Prohibited" is hereby amended to provide as follows: [New language underlined and in bold]

A. **ALL NIGHT PARKING PROHIBITED:** It shall be unlawful for the operator of any vehicle to park said vehicle on any street within the City of Country Club Hills between the hours of 3:00 A.M. to 6:00 A.M., including State Highways within the jurisdiction of the City.

This ordinance shall not apply to physicians on emergency cases nor to any emergency vehicles while engaged in emergency duties, or to a disabled vehicle while temporarily and unavoidably parked; provided, however, that in no case shall a disabled vehicle remain on any street longer than a twenty-four (24) hour period; and provided, further, that notice of disability of said vehicle shall be given to the Police Department.

Special permission may be granted for 3 consecutive days of overnight parking only, at the discretion of the Police Department.

A property owner overnight may park his or her vehicle in front of that owner's house for three (3) days in any thirty (30) day period.

Section 2: **Section 6.2.02E Amended.** Section 6.2.02E of the County Club Hills City

Code, "Restricted Parking on Snow Routes" is hereby amended to provide as follows: [New language underlined and in bold]

E. **RESTRICTED PARKING ON SNOW ROUTES; RESTRICTION ON PARKING IN FRONT OF MAILBOXES:**

It shall be unlawful to park any vehicle or to allow any vehicle to remain parked on any residential street within the City of Country Club Hills when there is two (2) or more inches of snow upon said street.

It shall be unlawful to park any vehicle or to allow any vehicle to remain parked on any residential street within the City of Country Club Hills within fifteen (15) feet of a mailbox. This restriction shall be enforced on a complaint basis only.

Section 3: Effective Date. This Ordinance shall be in full force and effect immediately upon its passage.
