Joanne Harris, resident of the Marycrest Subdivision. She commended everyone for the good work in the community. She mentioned that Facebook doesn't show the meeting dates. She also mentioned that our students in the community has no idea what is going on in the meeting. She asked if the City can work with the schools and have them make announcement of the Council Meetings to get them involved. She mentioned to Alderman Spivey about Southwood and the lighting, She said they are no school signs.
