## 5. COMMUNICATIONS AND REPORTS BY MAYOR FORD:

Mayor Ford next Wednesday is Lobby Day in Springfield and encouraged everyone to attend and meet with your legislators. Mayor Ford also shared the Homewood Casino may open the casino by the end of this year with the hotel portion to open at a later date. Mayor Ford then proceeded to share that casino license was issued with the guidelines of revenue sharing for up to 40 municipalities giving each municipality 3% of the revenue. HB4523 is in Springfield and is designed to have multiple municipalities share in the revenue of Amazon. He then shared there are 4-5 municipalities with Amazon facilities and this Bill is designed for the municipalities to share the revenue for which Country Club Hill has a very small facility that the city worked hard to get and it was not given to us yet we may have to share the revenues which are already small with other municipalities. Mayor shared he will be in Springfield next week and continuously to share his displeasure with this bill with our State Rep Meyers-Martin and Senator Hastings.
