Deanna Barbeara, MRK Properties shared her client has owned 18741 John since 2011 cannot obtain their rental license although they have completed their Crime Free Class, received a n occupancy certificate, heating, plumbing certs, etc. She shared the client wants to rent the property but was told they cannot. They also have another property with the same situation. She asked if the City Council would reconsider their restriction. She shared they met earlier in the day with Mayor Ford who suggested they attend this evening's meeting to ask for reconsideration on the rental decision for these houses. She then shared her clients who have rented these properties for over 11 and 14 years and it is a part of their income while providing housing for those who qualify and are in need.

Maurita Bivens, resident, inquired as to the protocol on issues. She inquired as to the protocol for sidewalk and fence replace. Lastly, she shared that Ald. Hutson intervened in her process.

Monique Perryman shared that she brought her property in 2018, her tenant moved out and her sister moved in with a section 8 voucher. She shared having her property available as a rental is her livelihood and she needs the rental restriction lifted.

Portia Lyons, resident, thanked Mayor Ford, Treasurer Burris and Ald. Hutson for their condolences as her 92-year-old mother recently passed away and she lost her son almost a year ago.

Nancy Switzer, resident, shared 26 months ago January 23, 2024 she shared the municipal codes are outdated and are in need of updating, the salaries are out of date, events need to be shared on Facebook and the website. She then shared Ald. Davis shared there would be a schedule for the street sweeper, and she has not seen it. Lastly she shared there are signs in

the 2<sup>nd</sup> Ward that say Lockett and she thought Ald. Lockett had termed out and she said the signs are confusing to voters.

Carl Washington, resident, he was pleased to hear commercials about the upcoming concerts. He is pleased to everything is going well and he looks forward to partnerships and looks forward to working with the Chamber of Commerce and the Department of Education.

Clifton, Graham, resident, shared the city is missing \$46 million, he addressed his concerns to Treasurer Burris, he asked Ald. Hutson and the Aldermen if they received health insurance, is there a line item and out of 5 Aldermen and a Mayor someone should know the answers.
